**CITY OF LOCUST GROVE  
NOTICE OF ANNEXATION REFERENDUM**

A referendum to determine whether the adoption of the annexation resolution by the City of Locust Grove should be ratified or rejected shall be held on March 1, 2016, contemporaneously with the presidential preference primary. Said referendum shall determine whether to expand the corporate limits of the City to include 247.38 +/- acres of land, which consists of those parcels listed below and depicted in the accompanying map, both of which are collectively referred to hereinafter as the "Property."

Only those persons registered to vote for members of the General Assembly residing, on the date of the adoption of the resolution, in the proposed area to be annexed (i.e., the Property) shall vote in the referendum. If a majority of those voting vote in favor of annexation, the Property shall become a part of the corporate limits of the municipality. Copies of the annexation resolution, report on the extension of municipal services, and waiver by Henry County consenting to the referendum, are available at the office of the City Clerk, 3644 Highway 42, Locust Grove, Georgia 30248.

The ballot question presented to the voters qualified to participate in the referendum shall read in substantially the same form as follows: "Shall the area of land approved by the Mayor and Council on January 4, 2016, for presentation to the voters, be annexed into the City of Locust Grove? Yes. No."

Polls will be open from 7 a.m., until 7 p.m., on March 1, 2016. Electors will vote in the same polling station as they do for city, county, state, and federal elections. Your polling place is shown on the voter's registration card furnished by Henry County. Alternatively, your polling place may be found by visiting the My Voter Page Web site at the following URL: [www.mvp.sos.ga.gov](http://www.mvp.sos.ga.gov). The last day to register to vote is February 1, 2016.
