The undersigned Bidder and Owner agree that this bid may not be revoked or withdrawn after the time set or the opening of bids, except as provided in Georgia law, but is an irrevocable offer that shall remain open for acceptance for a period of thirty days following the time set for the opening of bids.

If the undersigned Bidder is notified in writing by statutory mail of the acceptance of this bid within thirty days after time set for the opening of bids, Bidder agrees to execute within ten days the Contract for the Work for the above stated Bid, and at the same time to furnish and deliver to the Owner a Performance Bond and a Payment Bond, both in an amount of equal to 100 percent of the Contract Sum.

Upon the Effective Date of the Contract, the undersigned Bidder agrees to commence all preconstruction activities. Within ten days of the date specified in the Contract, the Bidder agrees to commence physical activities on the Site with adequate forces and equipment and to complete all work before January 31, 2014.


