



Homestead Exemption Regulations/Rules for 100% Exemption - 2026

EZ Form LGHE-EZ: IF you currently have the Henry County Homestead Exemption, use the **EZ Form** and provide 1 of the following documents:

- 1. GA Driver's License (for each person on deed)**
- 2. City of Locust Grove Voter's Registration Card (for each person on deed), or,**
- 3. Georgia ID Card (for each person on deed)**
- 4. Sign form with all persons on the deed in front of a Notary Public (available at City Hall).**

If you have NOT applied with Henry County Tax Commissioner's Office, please do so FIRST before filing with the City of Locust Grove.

All applications received through 5:00 PM on April will be processed for the CURRENT Tax Year (2026).

If you moved here after January 1, 2026, please wait until August 1, 2026 to make application for the 2027 Tax Year.

I, **the applicant**, am eligible as of January 1, 2026, and elect to apply for the following **City of Locust Grove (COLG) Homestead Exemption**: **COLG Basic Homestead Exemption (G1) 100% Exemption**

I understand that **Proof of Residence for City of Locust Grove** applicants is/are required to determine the owner's eligibility for the exemption. When filing by mail or in person, provide a copy of the following items along with the application: **City of Locust Grove Voter Registration or GA Driver's License or Georgia ID** at address for which I am applying.

I declare that I do not receive a Homestead Exemption on any other property in Georgia or in any other state either individually or by virtue of a trust. I declare under penalty of perjury and other penalties of state and local laws that I am eligible to claim the **City of Locust Grove Homestead Exemption** available to homeowners within the City of Locust Grove.
